The property built in 1819 forms a semi-detached stone built activity centre with side car parking for two vehicles.

Internally the property has the benefit of a basement games room; meeting hall and kitchen on the ground floor. As well as the first floor being fitted out with several bunk rooms and associated shower and W/C facilities.

The property is located and situated on Chapel Lane, within the heart of Greenmoor Hamlet. Offering easy access to the M1 motorway and local facilities.

The property has vast potential for conversion to multiple uses, subject to planning.
